Why do we do a PIT Count?



To measure & monitor trends & changes on local & national levels



To help understand what resources we need & strategize the best ways to use them to end homelessness



To comply with federal regulations & requirements



Point-In-Time Count

HUD Definition of Literally Homeless – Summary

- Primary nighttime residence is a public or private place not meant for human habitation
- Sleeping at a public or privately operated shelter



Point-In-Time Count

Literally Homeless – Summary Continued...

- Exiting an institution where they have resided for less than 90 days and resided in an emergency shelter or place not meant for human habitation prior to institution
- Fleeing/attempting to flee domestic violence and has no other residence and lacks resources to obtain other permanent housing



Why the last 10 days in January?

- Same time ensures consistency & trends monitored appropriately
- CoC likely maximizing resources.
 Counts those unable to access emergency shelter, other assistance.



Why the last 10 days in January?

- Public benefits beginning of month are likely exhausted

PIT Count Dos



Do get consent before asking PIT questions



Do remember that you may be entering into someone personal or private space



Do have a conversation with people you interview



Do respect peoples time



PIT Count Don'ts



Don't take personal photos



Don't ask questions in a way that assumes you know the answer



Don't force people to answer questions



Don't make promises you cannot keep

- Whatever roll we play We are all CES

- Standardized strengths & needs
 ASSESSMENT
- o <u>PRIORITIZATION</u> based on vulnerability
- REFERRAL cure experience & compliment needs

Youth Homelessness Response

- Rural Supportive Housing Initiative Rural Youth Peer Network – plans & action steps developed
- Youth Committee partnerships & coordination youth services/housing providers, DSS, & education
- Three Youth Surveys 30 total surveys completed in April, July, & Sept.

Youth Homelessness Response

- Youth Advisory Board (YAB) first meeting
 September 2019
- Foster Youth to Independency Initiative (FYI) housing voucher program
- Youth Homeless Demonstration Program (YHDP) Application – May 2020 – youth specific funding for housing and services



Youth Characteristics

Experiencing Homelessness

- o Transitional Age Youth (TAY) 16-24 years
- Can be difficult to serve/locate
- Underrepresented initially in CES
- Highly vulnerable population exploitation
- Many with foster care history
- Couch surf move regularly



FYI Initiative

Foster Youth to Independency Initiative

- 3 SD PHA's interested in participating
- Housing Voucher program for Transition
 Age Youth with child welfare, foster
 care, corrections experience
- Partnership between PHA's, DSS,
 SDHHC, & service provider (LSS)



FYI Initiative

- Up to 25 vouchers per year per participating PHA
- 36 months of rental assistance coupled with service options
