To date funds have not been expended for the period ending 8/31/2022. However, all allocated funds were not utilized as total funds are based on FMRs with the assumption that participant pays \$0 rent. Not all units rented at the area FMR, and some participants had income and paid a portion of rent. This resulted in less funds needed for rental assistance. Also, Administrative funds were based on a percentage of rental assistance funds. Since less than 100% of rental assistance funds were used there were less funds used for administration.

The Sioux Falls Housing and Redevelopment Commission (SFHRC) has been administering the Shelter Plus Care programs since 1995. This is the renewal of a Shelter Plus Care program which provides permanent housing with supportive services to 4 persons who are chronically homeless and have a diagnosis of severe, persistent mental illness. It is a collaborative effort between SFHRC and an agency partner, Southeastern Directions for Life. Persons are referred to the Program and Southeastern through the State of South Dakota's Coordinated Entry System. Both the SFHRC and Southeastern are in full compliance with Coordinated Entry for all of our CoC grants.

SFHRC provides scattered site tenant based rental assistance to program participants in a qualified housing unit of their choice within the city limits of Sioux Falls. SFHRC determines a person's eligibility, provides housing search information, determines the amount of rental assistance, provides security deposit assistance, if needed, and conducts a housing quality standards evaluation and qualification determination of the housing unit.

Southeastern encourages and engages program participants in cooperating and utilizing the supportive services provided by Southeastern and targeted towards the needs of the individual. These services include case management, housing search assistance, psychiatric/medication management, group therapy, psychosocial rehabilitation, vocational services and supervision. Southeastern also assists participants with identifying and accessing appropriate federal, state and local benefits.

The targeted population is extremely difficult to house and keep housed. This program is projecting to continue to 1)utilize at least 75% of the available beds annually; 2) Keep at least 75% of the participants stably housed in permanent housing for at least 180 days; 3) At least 25% of the participants will receive cash benefits.

In the future, the SFHRC and Southeastern hope to combine this grant with the 29-unit grant during this application round. These grants were initially started and served distinct populations. Presently, both grants serve the same population-in-need and would make sense to consolidate. Due to the shortened timeline for grant submittal and review this year, consolidation will not be pursued at the present time.
