The South Dakota Statewide Homeless Management Information System (SDHMIS) is administered by South Dakota Housing Development Authority (SD-500 CoC - collaborative applicant). SDHMIS is computerized data collection

application designed to capture client level information over time on the characteristics and service needs of homeless persons and families. The development of SDHMIS includes 1) bringing the power of computer technology to the day to day operations to individual homeless assistance providers. 2) knitting together providers and within the state in a coordinated and effective housing and service delivery system for the benefit of homeless clients 3) obtaining and reporting critical aggregate information about the characteristics and needs of homeless persons. 4) providing a source of data for decision making processes.
